China Three Gorges (Europe) S.A. (CTG Europe) was incorporated in Luxembourg on November 29, 2011. It is responsible for CTG's clean energy investment, development and operation in Europe and North America.



In the next step, CSAIL will promote the construction and operation of existing projects, further expand new markets, and propel equity diversification for a step-bystep development.



Established in 2020, China Three Gorges Latam Holding S.A.R.L (CTG LatAm) carries out clean energy investment, development and operation in Latin America (excluding Brazil). Currently, the company mainly undertakes hydropower, wind power and solar power projects in Mexico, Chile, Colombia, etc.

Next, CTG LatAm will build an international management team and participate in regional clean energy development. The company aims to improve the quality of international operations and contribute to regional economic and social development via winwin cooperation.
